By authority granted me under the provisions of Order No. R-2404-A, special authority is hereby granted to produce up to 500 MCF of gas per month from the above well until Notice of Release of Shut-In No. SF 4841 is issued by the Commission.

Until Notice of Release of Shut-In is issued by the Commission, if more than 500 MCF of gas is produced during any month, the special authority granted by this order shall be automatically revoked and the above well shut in until all over production is made up.
