DETAILS OF WORK

A. DV tool will be set for the protection of the Pictured Cliffs formation.

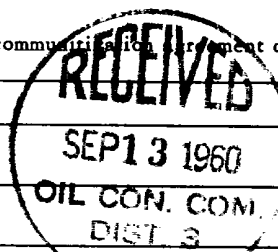

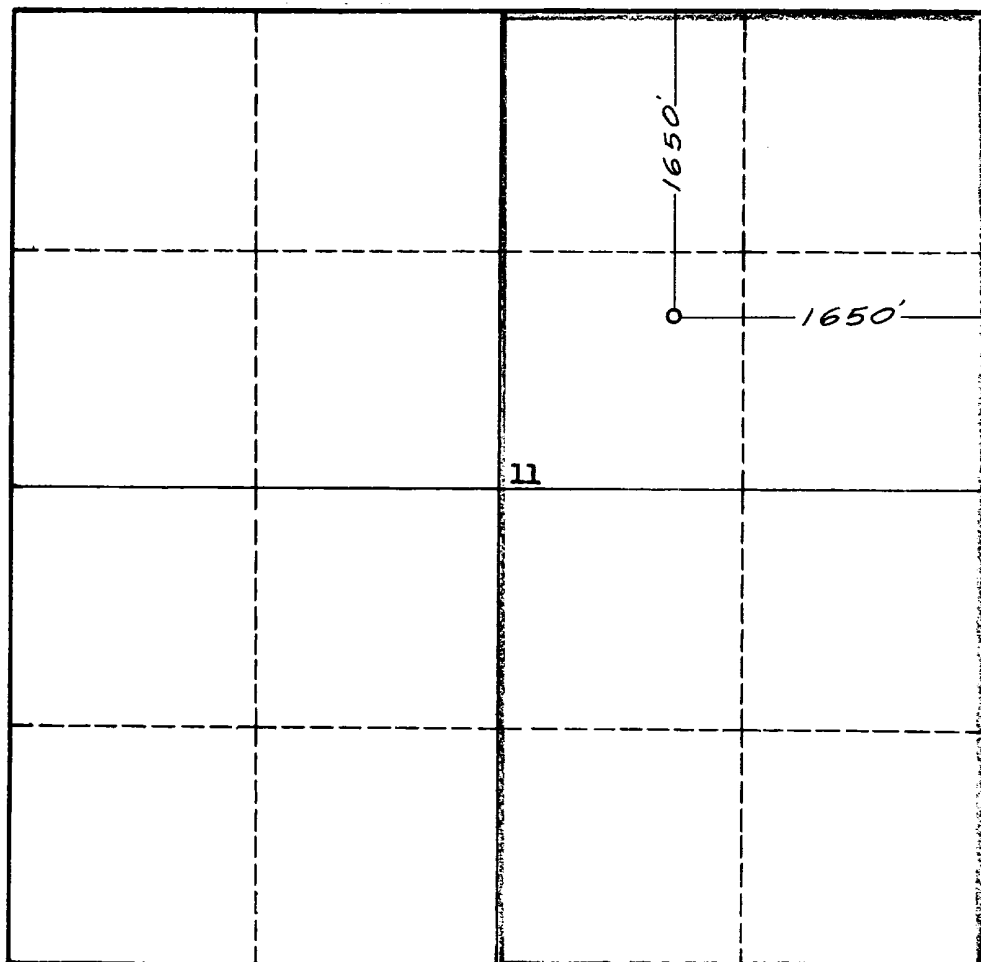
