Rig up, squeeze 50 sacks cement down 2 3/8" tubing into Dakota perforations, spot

30 sacks on top of casing perforations, 6299-6068', spot 60 sacks cement 5600'-5138', spot

40 sacks 1980'-1660' D.V. tool @ 1971', pull all free 5 1/2" casing spot 60 sacks 800'-650' spot

30 sacks 400 ft. 325' 10 sacks in top of surface, after cutting pipe off 4' below ground level,

no dry hole marker required. Agricultural area.
