THE METER NUMBERS AND PRODUCTION FOR THE WELL COMPLETIONS ARE LISTED. THESE WELL COMPLETIONS ARE METERED INDIVIDUALLY FOR ALLOCATION PURPOSES. THE WELL LOCATIONS FEED THE EL PASO METER # 72523 ON THE BLANCO # 2 WELL SITE. FOUR STAR OIL AND GAS IS THE DESIGNATED TRANSPORTER FOR ALL THE GAS FED TO THE CDP METER AT THE BLANCO #2 WELL SITE.
