1. MIRU a Mast Truck and Wireline Unit.
2. Lubricate in the hole w/a 1-3/8 " hollow carrier thru-tbg perforating gun with a gun GR/CCL and correlate to attached log sections. Shoot 5 holes as follows:
4730'- 1 JS
4728'- 1 JS
4726'- 1 JS
4724'- 1 JS
4722'- 1 JS
Total 5' - 5 holes
3. POOH w/ gun and shut in well pending notification of pipeline companies and EPS.
4. File new C104
5. Return well to production via 2-3/8" tbg string.
