4. Perforate the Fruitland Coal w/4 JSPF.
5. Fracture stimulate w/a minimum of 40,000# of sand.

B.O.P.E. will consist of a 2000# preventer equipped with pipe rams for the work string, blind rams, and a non rotating stripper head.
