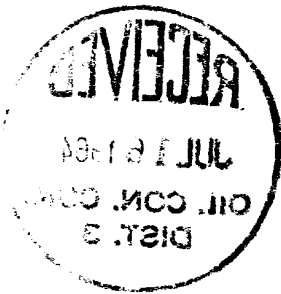

This has reference to Gas Supplement No. (NW) SF 5252 dated June 2, 1964, which provides for the shut in of the Pan American Petroleum Corporation's Charley Hosh No. 1, Basin Dakota Gas Pool, San Juan County, New Mexico. The Charley Hosh No. 1 is located in Unit B, Section 12, T-27-N, R-13-W. Attached is a map of the area showing the location of the Charley Hosh No. 1 and the proration unit dedicated to the well.

The Charley Hosh lease is an Indian Allotted lease which is beyond its primary term. The Charley Hosh No. 1 is the only well on the lease, and it is shut in under the above referenced Gas Supplement for being more than six times overproduced on the current monthly allowable. There is no shut-in royalty provision in the Indian Allotted lease form and, therefore, the Charley Hosh lease is in jeopardy unless it can be produced.

Pan American therefore makes application under the provisions of Order No. R-2404-A for special authority to produce up to 500 MCF of gas per month from the Charley Hosh No. 1 well until Notice of Release of Shut In No. SF 525' is issued by the Commission.
