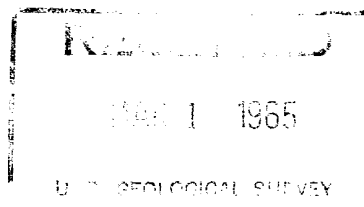

Pulled 1" tubing, cleaned out 12 ft. cavings to 2063. Ran Caliper and Gamma Ray Neutron Logs. Ran 3 1/2" OD 5.75# Grade B casing set at 2062. Cemented w/150 sx, good cement returns to surface. Perforated 2 holes/ft. 1998-2029. PBTB 2036. Frac w/30,000 gals. water, 22,500 lbs. sand, maximum injection rate 39 BPM. Cleaned out to 2036. Blew well clean and shut-in to install wellhead and gauges. Repair job complete.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
