12-2-93 MIRU A-Plus Well Service. ND tree. NU BOP. RIH w/2" open ended to 1802'. Plug #1 from 1802' to 1265' with 120 sxs. Class "B" cement over P.C. perms and Fruitland top. POOH with tubing and WOC. Shut well in. SDFN.

12-3-93 RIH and tagged plug at 1252'. Load well with wtr. and pressure test casing to 500#, held OK. POOH with tubing. Perforated 4 holes at 767'. RIH with a 7" cement retainer and set @ 702'. Pressure test tubing to 1000#. Plug #2 with cement retainer at 702' from 767' to 338' with 143 sxs. Class "B" cement, squeeze 76 sxs. below retainer and spot 67 sxs. above. POOH with setting tool and laid dn tubing. Perforated 2 holes at 141'. Established circulation out the bradenhead. Plug#3 from 141' to surface with 62 sxs. Class "B" cement. Circulated good cement out the bradenhead. Shut well in and WOC. ND BOP and cut off wellhead. Installed P&A marker with 20 sxs. cement. Rigged down.
