

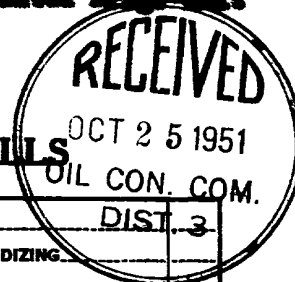

DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

1. Drill surface hole and run and set approximately 100' 8-5/8" surface casing and cement to surface.
2. Test surface casing, cement plug and drill to base of Pictured Cliffs sandstone at approximately 2000'.
3. Run electric log to total depth.
4. Run and set approximately 1700' of 5 1/2" 8-40 lbs casing on top of Pictured Cliffs sandstone and cement with 150 sacks of cement.
5. Move off rotary tools, test production string cement plug, drill cement plug, clean out to bottom and shoot with nitro shot.
6. Clean out after shot and complete well ready for production

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

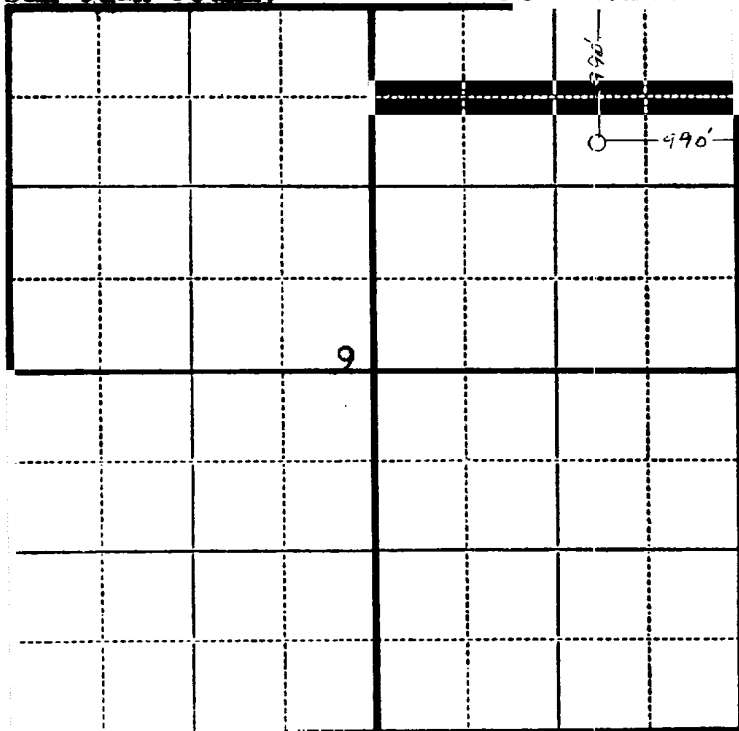
