(See Sundry Notice Form 9-331 for subject well, approved August 29, 1984). The measure of success achieved as a result of the recompletion of the Mudge "A" No. 7 is uncertain at this time since initial gas sales did not commence until 3-29-84. Until the Mudge "A" No. 7 has been on a producing status for a sustained period of time, the economic feasibility of recompleting this well is uncertain.
