Work commenced 6/12/98. Cleaned out wellbore, drilled out w/4 3/4" bit to 1904'. Spot 50 sks. C1. H cement w/2% CaCl2 + 1/4#/sk. celloflake cement plug from TD. Drilled out cement w/4 3/4" bit to 1902'. Ran 4" 10.46# FJ csg. to 1904'. Pumped 100 sks. C1. H cement w/10% Thixad (A10B) + 1% CaCl2 + 8#/sk. Gilsonite followed by 200 sks. C1. H cement w/2% CaCl2. Circulated to surface, TD correction (6' KB): TD 1913', PBD 1898'.

Logged. Perforated 1806'-1815'; 1828'-1832'; 1846'-1854', 2 SPF, total 46 holes. Broke down w/1000 gal. HCL & 75 ball sealers. Frac w/70Q N2 foam; used 391,000 SCF N2; 98,560# 20/40 Arizona sand and 10,400# 20/40 resin sand. Circulated hole clean.

Set 2 3/8" tbg. @ 1847'. Put well on 2" x 1 1/4" x 6' BHP. Set water tank, pumping unit, 2 phase separator & compressor. Turned well to sales line 7/8/98.
