The Schwerdtfeger No. 7 is completed in the Pictured Cliffs and has not been stimulated for a long time. We feel that the PC still has potential, but since we had limited success refracing the PC in the past, we would like additional time to study the formation before we P&A the wellbore. Study/work is scheduled for 2003. However, Marathon will do the following work to properly TA the wellbore.

1. RU pulling unit. ND wellhead. NU BOP. **THIS APPROVAL EXPIRES APR 20 2001**
2. TOOH w/1976' 1 1/2" 8rd tbq. TIH w/4 11/16" overshot on 2 3/8" tbq and retrieve fish (838' of 1" line pipe). TOOH.
3. TIH w/bit & csg scraper to 1860'. POOH.
4. TIH w/5 1/2" CIBP for 14# csg. Set at 1841'. Open hole from 1901-1981'. Btm csg at 1901'.
5. Circulate 2% KCL w/corrosion inhibitor.
6. Test csg/CIBP to 500 psi for 30 min. (If MIT fails, TOOH, PU pkr and isolate leak.)
7. TOOH laying down tbq.
8. ND BOP. NU wellhead. RD pulling unit.

If csg/CIBP fails MIT, an AFE will be written to obtain approval to repair or P&A wellbore.
