Due to the failure of the subject well to produce commercial quantities of gas, it was plugged and abandoned September 12, 1974 as follows:

- 1. Pulled the 1" tubing.**
- 2. Squeezed 65 sacks Class "A" Neat Cement in open hole.**
- 3. Perforated casing with 2 holes at 1250'.**
- 4. Set a cement retainer at 1150' and squeezed below retainer with 100 sacks Class "A" Neat cement with maximum squeeze pressure of 1000 psi.**
- 5. Spotted a surface plug and erected a P&A marker.**
- 6. Cleaned up and reseeded location.**

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
