Ladies and Gentlemen:

In response to your letter dated June 23, 1994, the following information will provide a current status of the three properties being reviewed.

- #1. No. 154 Gallegos Canyon Unit, 790' FNL & 1530' FEL, Sec 27, T. 29 N., R. 12W., Lease No. NMSF-079907. Shut in approval expired May 1, 1994. The surface facilities were to be repaired and the well returned to production.

During early 1994, the well was vented unload. The venting procedure indicated that there was not enough pressure for production or to justify the cost of the repairs. The well has been placed on Amoco's Recompletion/Plug & Abandon Review list. A decision will be made regarding the future status of this well by September 30, 1994, at which point our procedures and request for approval will be sent to the Bureau of Land Management.

- #2. No. 147 Gallegos Canyon Unit, 900' FSL & 990' FEL, Sec. 4, T. 27 N., R 12 W., Lease No. NMSF-078902. Shut in approval expired March 1, 1994. The well was to be cleaned out and returned to production.

During February 1994, cleanout of the well was attempted. It was unsuccessful. The well has been placed on Amoco's Recompletion/Plug & Abandon Review list. A decision will be made regarding the future status of this well by September 30, 1994, at which point our procedures and request for approval will be sent to the Bureau of Land Management.

3. No. 1 Leeper Gas Com C, 820' FSL & 1850' FWL, Sec. 34, T. 32 N., R. 10 W., Lease No. NMSF-078604-A. Shut in approval expired May 16, 1994. P&A procedure was to be submitted.

The P&A procedures are being prepared and will be forwarded to your office within the next week.
