Since this well's production has dropped below the economic limit without possibility of increasing production, we plugged and abandoned it in the following manner on December 12, 1967:

1. Moved in and pulled tubing.
2. Pumped 35 sacks down casing and squeezed 7 sacks into formation. Top of cement plug 1820'.
3. Loaded hole with mud.
4. Spotted 5 sacks cement 40' to surface.
5. Got off wellhead, erected PMA marker, and cleaned up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
