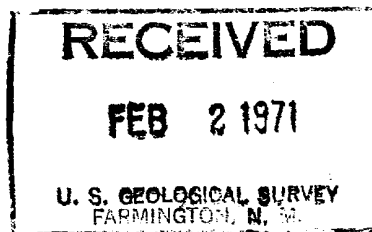
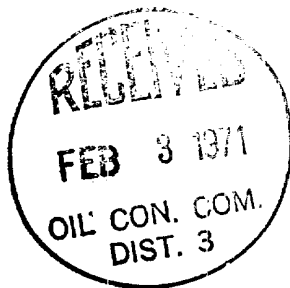

- 1. Rig up Unit. Pull 1-1/2", R.U.E. tubing and check tubing for holes or leaks.**
- 2. Set 4-1/2" Baker Model "W" bridge plug at approximately 6175 ft. R.I.B. to shut off possible water entry from lower Dakota.**
- 3. Run 1-1/2", R.U.E., 2.90%, JCM tubing. Set at approx. 6156 ft. R.I.B.**

Instructions
