Louis Dreyfus Natural Gas Corp. currently plans to plug and abandon the Mudge A #7 well according to the approved intent dated 4/14/98. We also anticipate drilling a replacement well, the Mudge A #7R. The replacement well has been proposed and is currently pending approval internally and by our partners. If a replacement well is drilled, the Mudge A #7 will be plugged. If the replacement well is not drilled, LDNGC will re-evaluate the existing wellbore for a possible recompleation. In either event, LDNGC reasonably expects to plug the Mudge A #7 or to file an intent to recompleate by December 31, 1999.
