Perforated 1820'-1835', 4 SPF, 38 holes. Acidized w/1000 gal. 15% HCL & 104 ball sealers. Frac w/70Q N2 foam. Used 110,000# 20/40 sand and 399,000 SCF N2.
Ran 2 3/8" 4.7# J-55 tbg. to 1803'. Put well on pump (1 1/4' x 10'). Hooked up 2 phase separator, compressor and installed 100 bbl. fiberglass tank.
Well turned to sales line 7/17/98.
