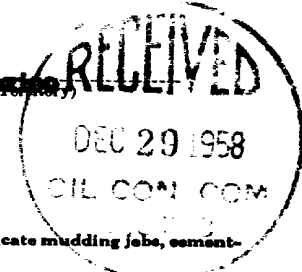
DETAILS OF WORK

Well to be drilled into top of Morrison formation at approx. 6650' KB with rotary tools.

1. Set approx. 250' of 10 3/4" OD, 32.75#, H-40 surface casing.
2. Drill into the Morrison formation.
3. Set approx. 6650' of 5 1/2" OD 15.8# J-65 casing with cement staging collars below the base of the pictured cliff and the base of the Gallup formations.
4. Complete well as a Dakota gas well.
5. Expected tops:

Pictured Cliffs - 2800'	Gallup - 5000'
Cliff House - 3400'	Tecilo - 5000'
Point Lookout - 4300'	Dakota - 6400'
Mancos - 4500'	Morrison - 6650'

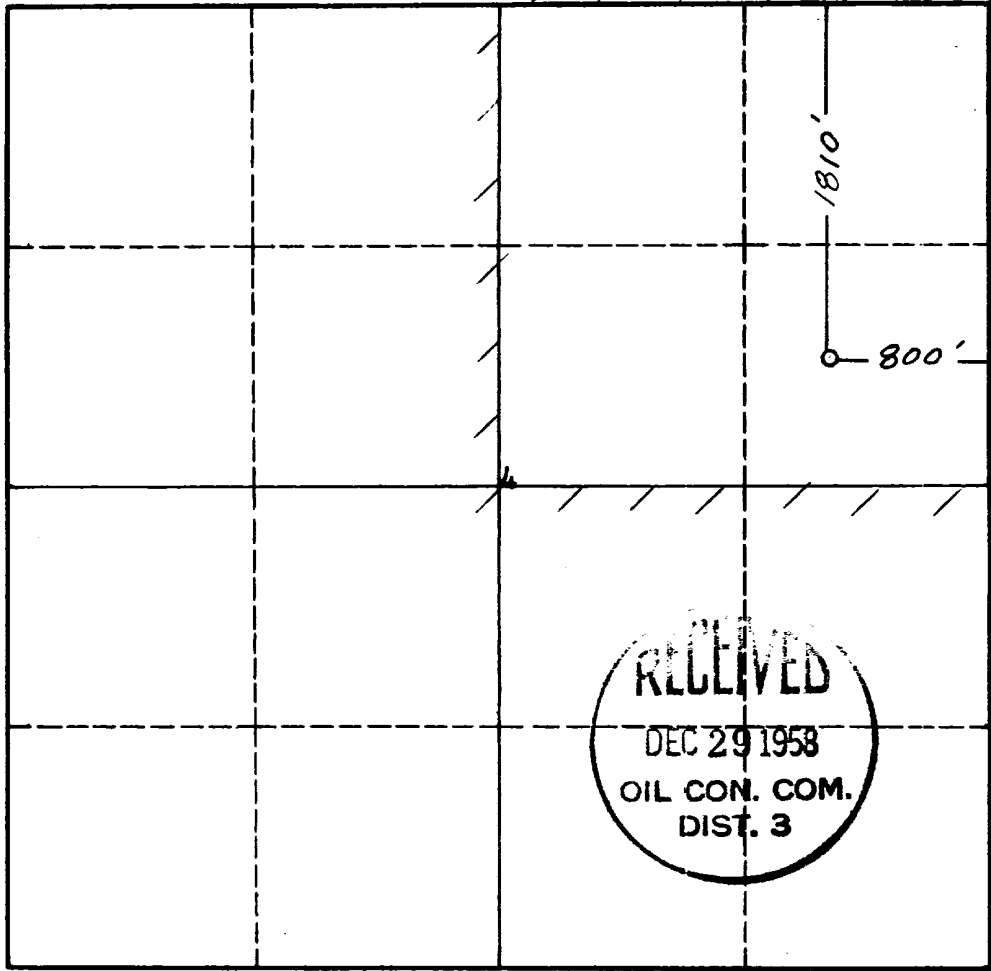
