DETAILS OF WORK

A DV Tool will be set for the protection of the Pictured Cliffs formation.

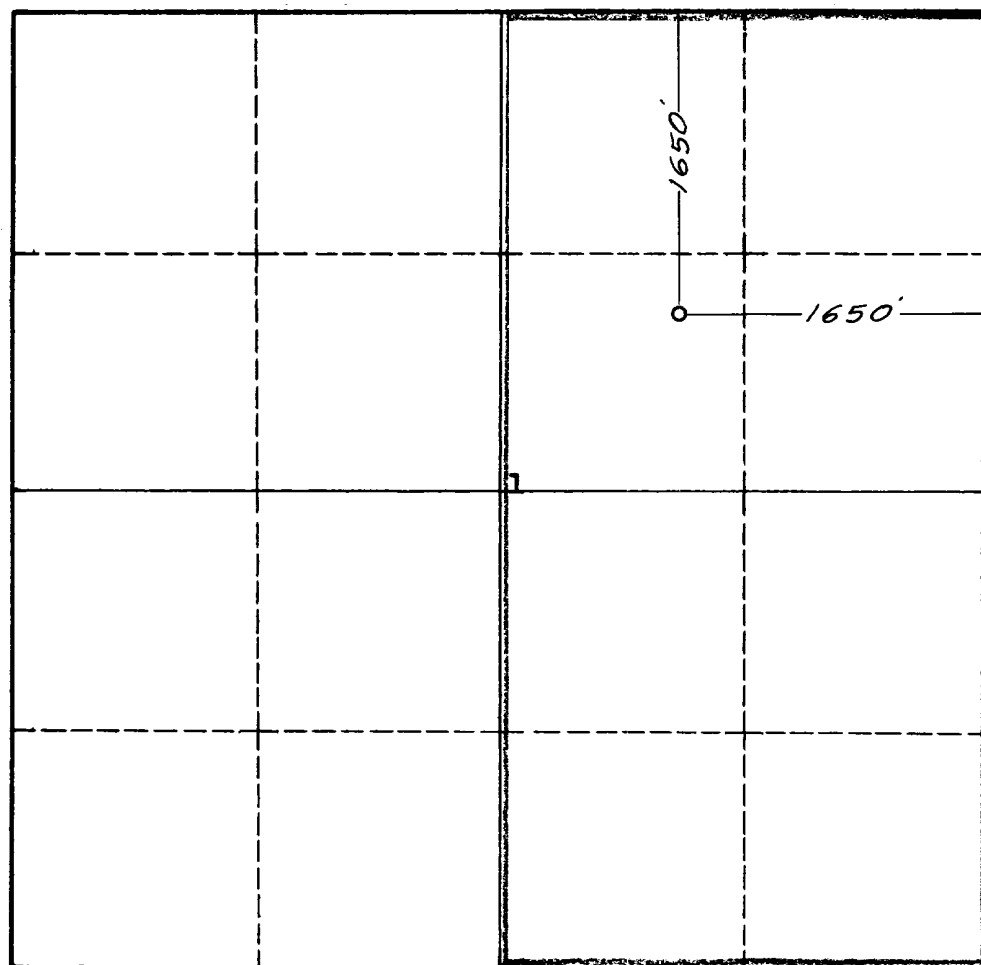
