Ran CBL, CCL, GSL. Perforated 1558'-1576', 1584'-1598', 2 SPF, 64 holes. Pumped 500 gal. 15% HCL & 98 ball sealers. Frac w/70Q N2 foam; used a total of 355,000 SCF N2; 89,780# 20/40 Arizona sand and 10,520# resin coated sand. Circulated hole clean.

Ran 2 3/8" tbg., set @ 1600'. Put well on 2" x 1 1/4" x 10' RHAC-Z BHP. Set compressor, separator, pumping unit. Turned well to sales 1/29/99.
