Benson-Montin-Greer Drilling Corp. owned and operated Douthit #1 Dakota gas well located on Federal lease #SF-078010. This lease expired and the half section portion of the lease containing the Douthit #1 was purchased by B-M-G at the Federal Oil & Gas Lease sale this past July, 1992 - with new lease #NM 89130 effective September 1, 1992 and containing 319.28 acres.

B-M-G as owner operator of Federal Oil & Gas lease #NM 89130 proposes to swab test the well to determine present oil, gas and water productivity and if the test indicates volume of gas and oil in paying quantities at todays prices then restore well to production status.

B-M-G expects to complete test and make a decision on the Dakota within 90 to 120 days.

THIS APPROVAL EXPIRES JAN 01 1993

In the event the Dakota formation does not test in paying quantities then B-M-G will follow the plugging procedure set out in previous Sundry Notice dated 1/14/92 with exception that B-M-G may elect, subject to B-L-M approval to test other formations for gas or oil.
