On July 13, 2000, Amoco Production Company submitted for your approval a Sundry Notice requesting permission to maintain the subject well in a shut-in status pending review of potential repair to restore well to production status. We respectfully request permission to continue the shut-in status pending our well by well review to determine if an attempt may be made to restore it back to production status either in the existing zone or uphole and avoid premature abandonment of possible reserves. We anticipate completion of well review in the 4th quarter of this year for all wells in the San Juan Basin. If review indicates no potential exist for this well we will submit plugging procedure for your approval.
