

DETAILS OF WORK

It is proposed to complete a gas well in the Pictured Cliffs sandstone at approx. 2000'. Approx. 100' of 8-5/8" surface casing will be cemented and circulated with 50 sacks. Approx. 1900' of 7" casing will be cemented with 100 sacks 5' in the Pictured Cliffs. Rotary tools will be used to the casing point and the test will be drilled in with cable tools. The Pictured Cliffs will be shot with approx. 250 quarts of SNE and cleaned out and completed.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.





