Drilled 8-3/4" hole with rotary tools to 1232' in sand. Set and cemented 1274' (40 jts.) of 7" O.D., 20#, J-55 New seamless casing of 1232' with 175 sacks common cement. Completed cementing @ 6:00 P.M. 12-6-53. Moved off rotary tools and moved in cable tools to complete well.

On 12-9-53, bailed hole dry. Let stand 4 hrs. Hole remained dry. Drilled cement plug at 4:00 P.M., 12-9-53. Hole bailed dry. Casing and cement tested O.K.
