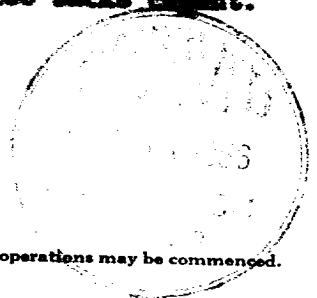

DETAILS OF WORK

1-9-56. Total Depth 5000'.

Run 128 joints 5 1/2", 15.50#, J-55 casing (4990') set at 5000' with 150 sacks regular cement, 150 sacks Pozmix, 2% Gel. Bridged over with top cement at approximately 3700'. Perforated at 4670' with 4 shots, squeezed with 100 sacks cement. Perforated at 4434' with 4 shots, squeezed with 100 sacks cement. Perforated at 4220' with 4 shots. Would not breakdown.
