El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit consisting of the W/2 (Lots 1, 2, N/2 SW/4, NW/4) of Section 32, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

- The Phillips #1 Well, located 890' from the South line and 800' from the West line of Section 32. Township 28 North, Range 8 West, was completed as a gas well from the Mesaverde Formation on October 26, 1956.
- That the proposed non-standared gas proration unit consists of 305.87 acres which are contiguous quarterquarter sections and lots.
- That the proposed non-standard gas proration unit lies wholly within a single government section.
- That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.


