During the process of the completion of the subject well into the Blanco Mesaverde Pool (perf and frac of Point Lookout completed - during attempt to set isolation to perf and frac Menefee) a leak in the casing was encountered @ approximately 3500' (Chacra formation). Per telephone conversation and verbal approval granted by Jim Lovato on 01/10/2002, Amoco will perform the following casing repair:

TIH with tubing and packer. Set packer at 3300'. Squeeze casing leak as per Schlumberger procedure. TIH with tubing and bit. Drill out cement and pressure test squeeze to 500 psi. Run CBL from 2200' - 3900' to verify cement isolation between PC, Chacra, and Mesaverde. Continue completion operations (Perf & Frac Menefee, DO CIBPs & downhole commingle with the Basin Dakota) in accordance with Sundry Notice approved on 08/06/20.
