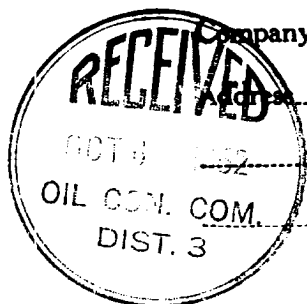

Held 500# for 30 minutes.

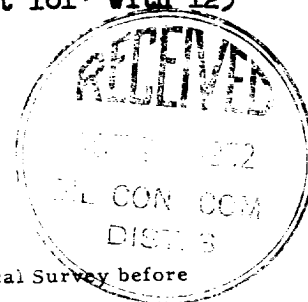
