of Order No. R-128-C for Non-Standard
Proration Unit, Blanco Mesaverde Gas
Pool, San Juan County, New Mexico.

Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard unit comprising the South Half (S/2) (or SE/4 SE/4, SW/4 SE/4, SE/4 SW/4, SW/4 SW/4, Lots 1, 2, 3 and 4) of Section 10, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts.

1. The Jones #1-A Well, located 800 feet from the South line and 1550 feet from the West line of Section 10, Township 28 North, Range 8 West, San Juan County, New Mexico, was completed as a gas well on March 30, 1955.
2. That the proposed non-standard gas proration unit consists of 293.84 acres which are contiguous quarter-quarter sections and lots.
3. That the proposed non-standard gas proration unit lies wholly within a single government section.
4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.



Therefore, El Paso Natural Gas Company requests that under the provision of Rule 1 (b) of Order No. R-128-C, the Secretary of the Commission grant exception to Rule 1 (a) without Notice and Hearing, and approve the subject non-standard gas production unit.

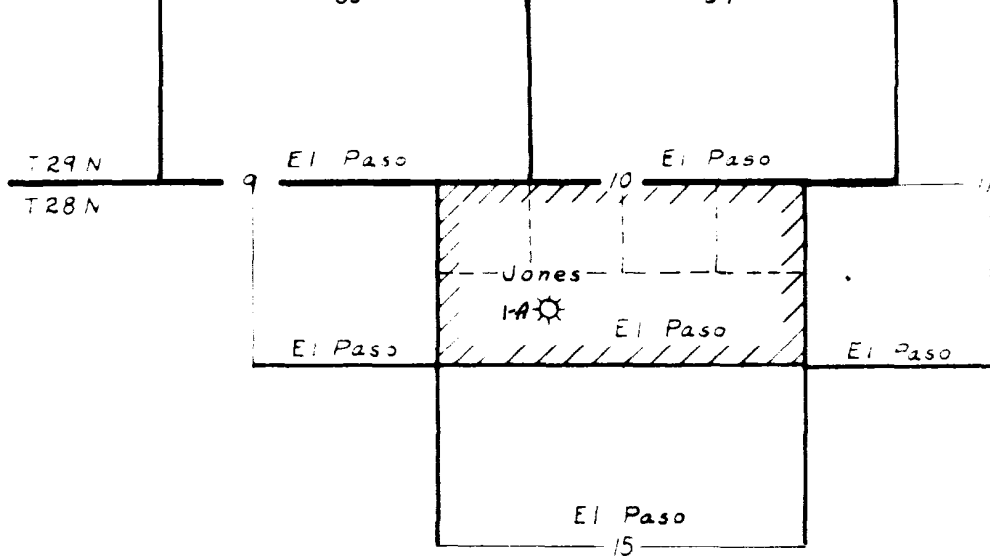
