Gentlemen:

El Paso Natural Gas Company hereby submits its application for administrative approval of a non-standard proration unit comprising the South Half (S/2) (or SW/4 SE/4, SE/4 SE/4, SE/4 SW/4 and Lots 1,2,3,4, and 5) of Section 7, Township 28 North, Range 8 West, San Juan County, New Mexico, and in support thereof states the following facts:

- 1. The Riddle #1-G well, located 990 feet from the South line and 990 feet from the East line of Section 7, Township 28 North, Range 8 West, was completed as a gas well on April 27, 1953, and connected to El Paso Natural Gas Company's gathering system June 16, 1953.
- That the proposed non-standard gas proration unit consists of 298.76 acres which are contiguous quarter-quarter sections and lots.
- 3. That the proposed non-standard gas proration unit lies wholly within a single governmental section.
- 4. That the proposed non-standard gas proration unit may reasonably be presumed to be productive of gas.
- 5. That by copy of this letter of application all operators owning interests (a) in the section in which any part of the non-standard proration unit is situated and which acreage is not included in said non-standard gas proration unit, and (b) in acreage offsetting the non-standard gas proration unit, are notified by registered mail of this proposed non-standard gas proration unit.


