* As of this date, this location has not been physically staked. Terrain permitting, well will be drilled as above shown. If not, location will be moved to an accessible location, within the spacing rules of United States Geological Survey and the State of New Mexico. Certified location plat will follow.

It is proposed to drill this well with rotary tools to a depth sufficient to test the Mesaverde formation. 8-5/8" casing will be set at approximately 200' and cemented top to bottom. 7-7/8" hole will be drilled to approx 5800', well logged. If productive in both Pictured Cliffs and Mesaverde, 5-1/2" casing will be set and cemented with sufficient cement to protect all zones. Productive zones will be perforated, treated if necessary, and well dually completed in Mesaverde and Pictured Cliffs.

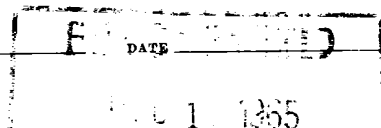

Instructions

General: This form is designed for submitting proposals to perform certain well operations, as indicated, on all types of lands and leases for appropriate action by either a Federal or a State agency, or both, pursuant to applicable Federal and/or State laws and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 14: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.

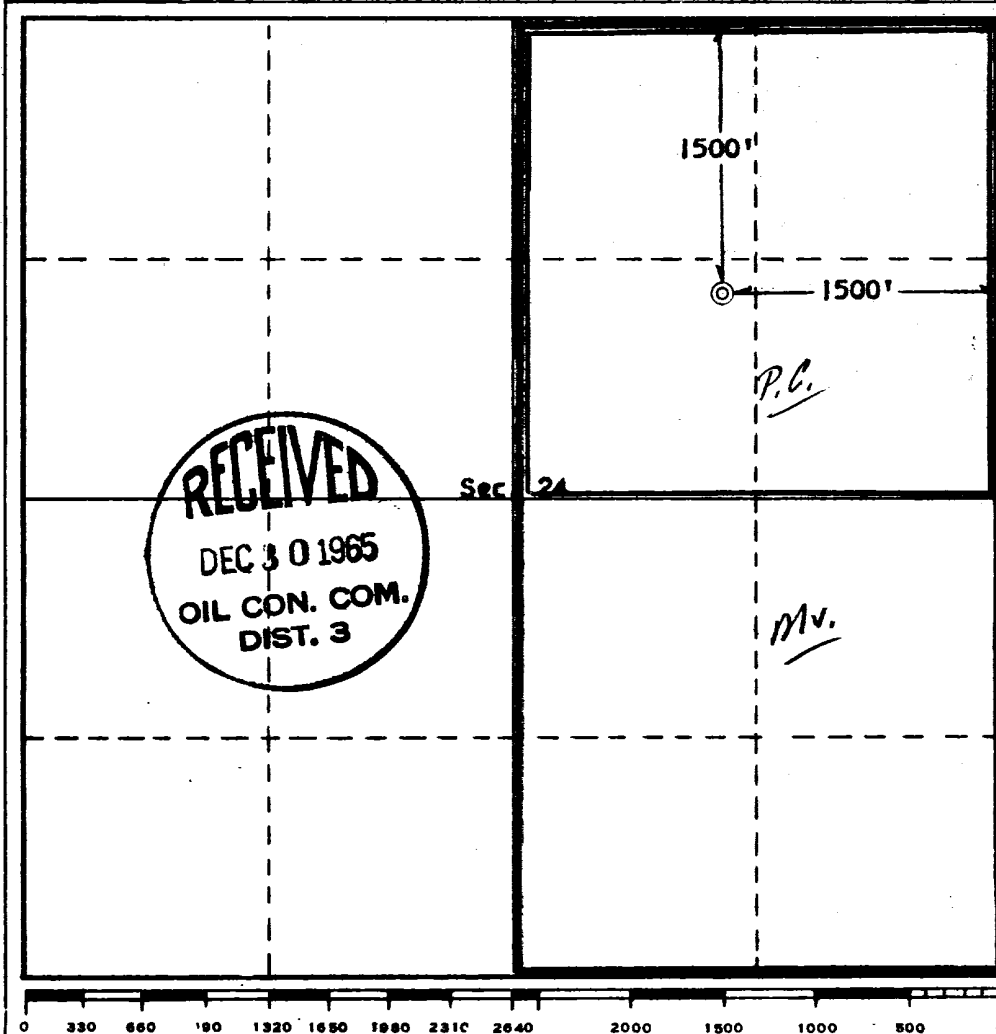
