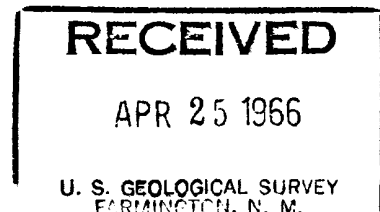

Instructions

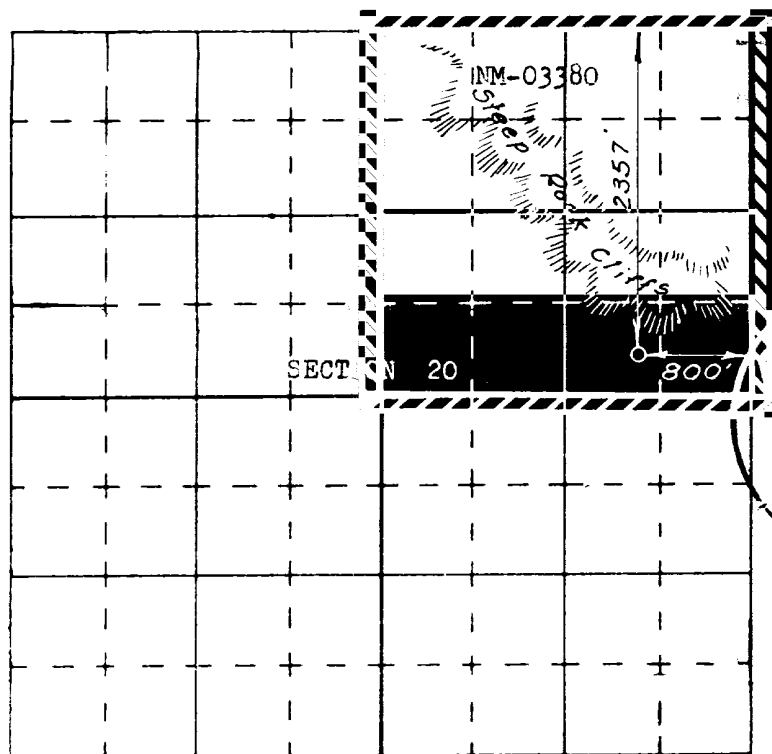
