05-03-93 Dump sand on BP @ 5520'. Stuck bailer. Fishing. Recovered fish. Fill hole w/KCL wtr. PT csg 1000#, ok.

05-04-93 Dump sand on BP @ 5520'. Ran CBL. Perf 5033-4670'.
