First stage to fill to top of Gallup, second stage to cover Mesa Verde, and third stage to fill from Lewis to base of Ojo Alamo. Dakota and Mesa Verde pay zones will be selectively perforated and sand-water fractured.

The W/2 of Section 35 is dedicated to this well.



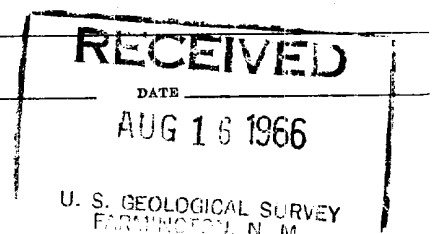

Instructions

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 14: Needed only when location of well cannot readily be found by road from the land or lease description. A plat, or plats, separate or on this reverse side, showing the roads to, and the surveyed location of, the well, and any other required information, should be furnished when required by Federal or State agency offices.
