On 8-18-66 spudded well and drilled surface hole.

On 8-19-66 ran 9 joints 9 5/8", 32.3#, H-40 casing w/180 sacks cement circulated to surface. W.O.C. 12 hours, tested w/600#/30 minutes O. K.

On 8-30-66 Total depth 6890'. Ran 208 joints 5 1/2", 15.5#, J-55 casing and 9 joints 7" 23#, J-55 casing (6877') set at 6890'. Float collar at 6859', stage tools at 4672' and 2345'. Cemented first stage w/190 sacks cement, second stage w/120 sacks cement, third stage w/90 sacks cement. W.O.C. until well completion on 10-20-66, tested casing w/3800# O. K.

On 10-20-66 spotted 500 gallons 7 1/2% MCA. Perf. Dakota formation 6580-84, 6640-56, 6717-23, 6768-84' w/16 SPZ. Frac w/48,000# 40/60 sand, 48,210 gallons of water, Max. pr. 3800#, BDP 1600#, tr. pr. 2400-2750-3600#. I.R. 60 BPM. Dropped 3 sets of 16 balls each, flushed w/6990 gallons of water. ISIP 1200#, 5 Min. 900#. Set BP @ 4650', perf. Mesa Verde formation 4503-12, 4550-59, 4569-87' w/18 SPZ, frac w/40,000# 20/40 sand, 40,250 gallons of water. Max. pr. 3800#, BDP 1800#, tr. pr. 1800-2200-2600#. 72 BPM, dropped 2 sets of 18 balls each, flushed w/4630 gallons of water. 5 Min. 500#.

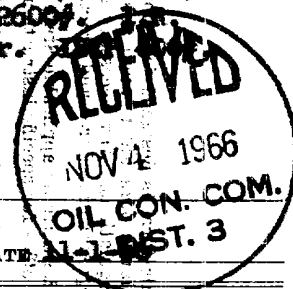

Instructions

General: This form is designed to submit proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices. In addition, such proposals and reports should include reasons for the abandonment; data on any former or present productive zones, or other zones with present significant fluid contents not sealed off by cement or otherwise; depths (top and bottom) and method of placement of cement plugs; mud or other material placed below, between and above plugs; amount, size, method of parting of any casing, liner or tubing pulled and the depth to top of any left in the hole; method of closing top of well; and date well site conditioned for final inspection looking to approval of the abandonment.
