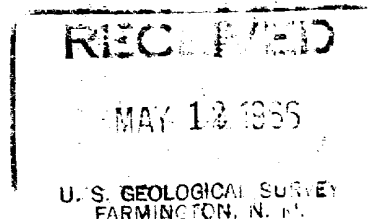

Spotted 80 sack cement plug from 5575' to 5675', 120 sack cement plug from 5100' to 5300', 55 sack plug from 4750' to 4850', 55 sack plug from 3100' to 3200', 80 sack plug from 2450' to 2550' and a 55 sack plug from 950' to 1050'. Cut off casing head and welded a plate with a dry hole marker on top of 10-1/4" casing.
