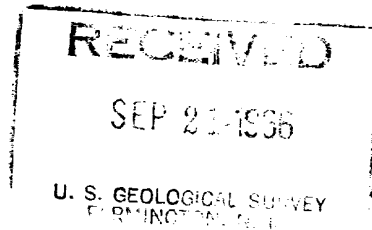
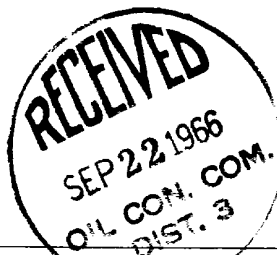

On 8-30-66 spudded well, drilled surface hole and ran 9 joints 8 5/8", 24#, J-55 casing (294') set at 309' w/210 sks. cement. W.O.C. 12 hours. Tested 600#/30 min. O. K.

On 9-14-66 total depth 6722', ran 211 joints 4 1/2", 10.5#, J-55 casing (6708') set at 6722'. Float collar at 6689', second stage tool at 4530', third stage tool at 2161'. Cemented first stage w/270 sks. cement, second stage w/120 sks. cement, third stage w/140 sks. cement. W.O.C. 18 hours, tested w/4000#/30 min. O. K.

On 9-17-66 spotted 250 gallons 7 1/2# MCA, perf. Dakota @ 6478-62' w/4 SPF; 6494-6510' w/1 SPF; 6601-15' w/2 SPF; 6625-29' w/4 SPF, frac w/50,000# 40/60 sand, 50,130 gal. water, max. pr. 4000#, BEP 1000#, tr. pr. 3200-3800-4000#. I.R. 29.2 BPM. Dropped 1 set of 16 balls, and 2 sets of 8 balls, flushed w/5220 gal. water. BEP 1600#.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
