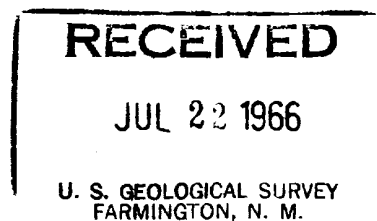

The production casing will be cemented in 3 stages with sufficient cement to cover Dakota formation on first stage, Mesa Verde formation on second stage, and Pictured Cliffs and Kirtland formations on third stage. Selective zones in the Dakota formation will be perforated and sand-water fractured.



The S/2 of Section 34 is dedicated to this well.

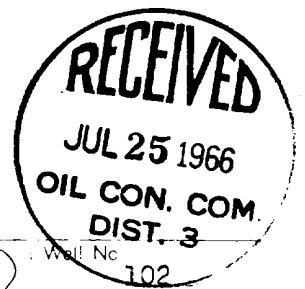
