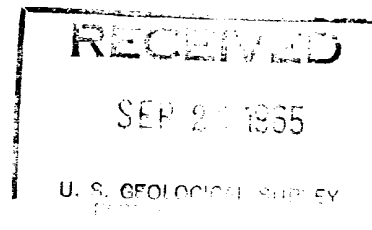

On 9-16-65 total depth 6935'. Ran 214 joints 4 1/2", 10.5#, J-55 casing (6922.71') set at 6934.71'. Stage tools set at 4964' and 2462'. Preceded first stage w/GP-100, cemented with a slurry of 450 cu. ft. consisting of a ratio of 1:1 Pozmix "S" and Class "A" cement, 2% gel, 1/4# Flocele/cu. ft., 2% calcium chloride. Second stage with a slurry of 400 cu. ft. consisting of a ratio of 2:1 Pozmix "S" and Class "C" cement w/1/4# Flocele/cu. ft. and 1/4 cu. ft. Strata-Crete "5"/cu. ft., 2% calcium chloride. Third stage w/a slurry of 400 cu. ft. consisting of a ratio of 2:1 Pozmix "S" and Class "C" cement w/1/4# Flocele and 1/4 cu. ft. Strata-Crete "6"/sk., 2% calcium chloride.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
