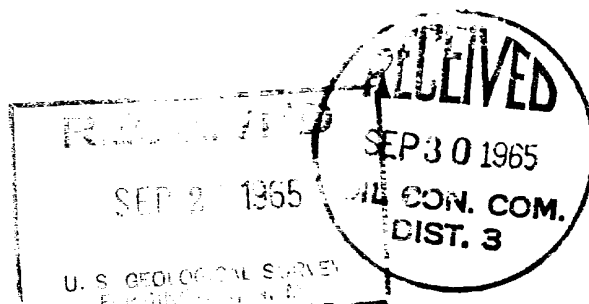

Max. pr. 4400#, BDP 1200#, tr. pr. 3300-3480-4400#. Flush w/5230 gallons. I.R. 43 BPM. Dropped 4 sets of 8 balls each. ISIP 1000#, 5 Min. 800#.

Instructions
