Texaco E&P Inc. requests approval to lay a gas gathering line on the subject lease. This line will stay within the bounds of the lease and will service only wells on this lease. All construction will be contained within the SW 1/4 of Section 11, T27N-R09W.

This 945' line will consist of two segments. The first segment will be 415' in length from Nellie Platero #6 to Nellie Platero #3 and will be buried partially within the road ROW. The second segment will be 530' in length and buried within an existing EL Paso pipeline ROW located between Nellie Platero #5 and Nellie Platero #3.

Provisions and Materials:

- '945' of 2" & 2 1/2" wrapped, schedule 40, steel line pipe. Connections will be welded.
- Pipeline crossing will be marked and buried to 48"
- Line will be pressure tested to 1000 psi... (Anticipated working pressure will be 70 psi)
- Maximum width of disturbance will be 30'

To consolidate compression, Texaco proposes to install two (2) flowlines on the Nellie Platero lease.

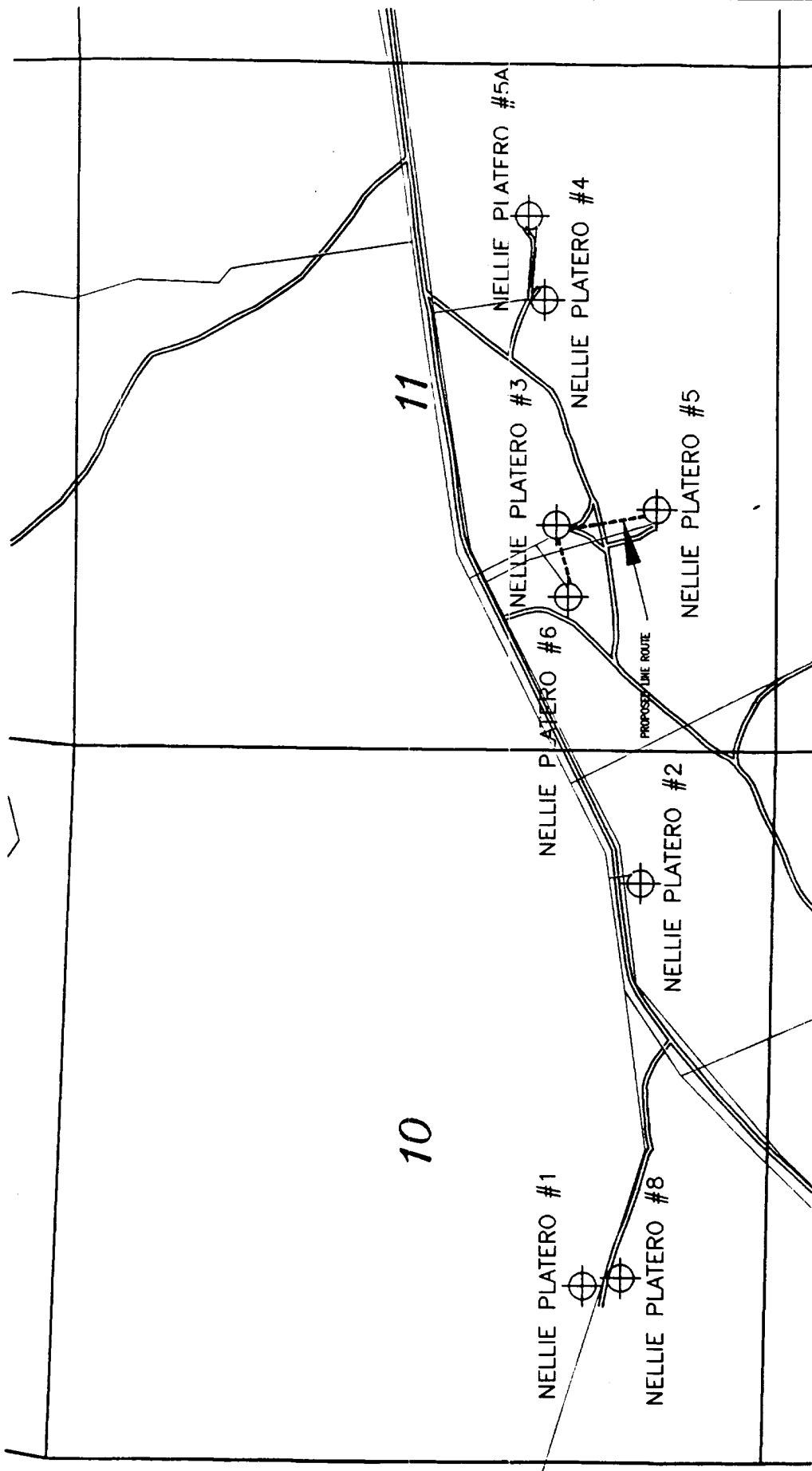
