DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

Spudded 12-1/4" hole November 26, 1959, and drilled to 352'. 7-3/8" casing was set 352' with 200 sacks cement containing 2% calcium chloride. Cement circulated. After waiting on cement, casing and water shut off were tested with 800 psi for 30 minutes, which held with no indication of pressure drop. Reduced hole to 7-7/8" at 352' and resumed drilling.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
