

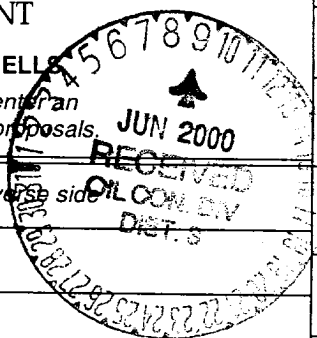

7. Clean out well to CIBP @ 6,030'.
8. TIH w/prod tbg & RWTP.
9. RDMO PU.
