## Gentlemen:

Complying with Rule No. 112-A, Multiple Completions, we are filing application for administrative approval to dually complete Fullerton #3 as a Gallup Sand and Dakota Sand producer. The well is to be completed as an oil over gas dual completion and the hydrocarbons from each of the two zones will be safely and efficiently produced through parallel strings of tubing. Each tubing string will be 2-1/16" CD, 1.75" ID, 3.3# per foot, JOW-50 with Aztec IJ tubing joints. A Baker Model "D" production type packer will be used to segregate the separate zones of the dual completion and will effectively prevent communication between all producing zones. Attached to this letter you will find two copies of the application, "Application For Dual Completion," and two copies of the following information:

- (A) Diagramatic sketch of the dual completion.
- (B) Plat showing the location of all wells on applicant's lease, all offset wells on offset leases, and a list of the names and addressees of operators of all leases offsetting applicant's lease.
- (C) Evidence that said offset operators have been furnished copies of the application.
- (D) Electrical logs of the well with tops and bottoms of producing zones and intervals of perforation indicated thereon.

Rule 112-A states that the Secretary-Director shall have the authority to grant an exception to the requirements of Rule 112-A (I) and to approve the dual completion of a well without notice and hearing if the well is to be dually completed within the limits of two defined pools or within one mile thereof, and the Commission has previously authorized the dual completion of a well in the same zones as proposed, after notice and hearing.

Commission approval was given to Western Natural to dually complete their Schlosser #1 located in the C NE NW Section 10-27N-11W by Order No. R-1577 dated January 18, 1960. Commission approval was given to British-American to dually complete their Fullerton #6 located in the SW NW Section 11-27N-11W, San Juan County, New Mexico by Order No. DC-959 dated June 27, 1960.

We respectfully request administrative approval to dually complete our Fullerton #8 under your authority as stated in Rule No. 112-A.




