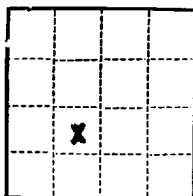

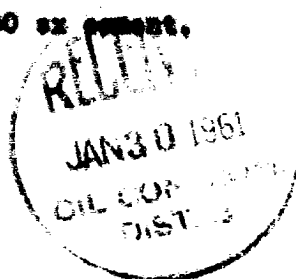
### DETAILS OF WORK

Will perforate and sand-water frac the Dakota formation.

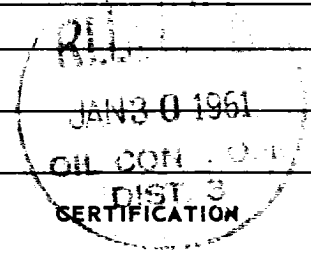

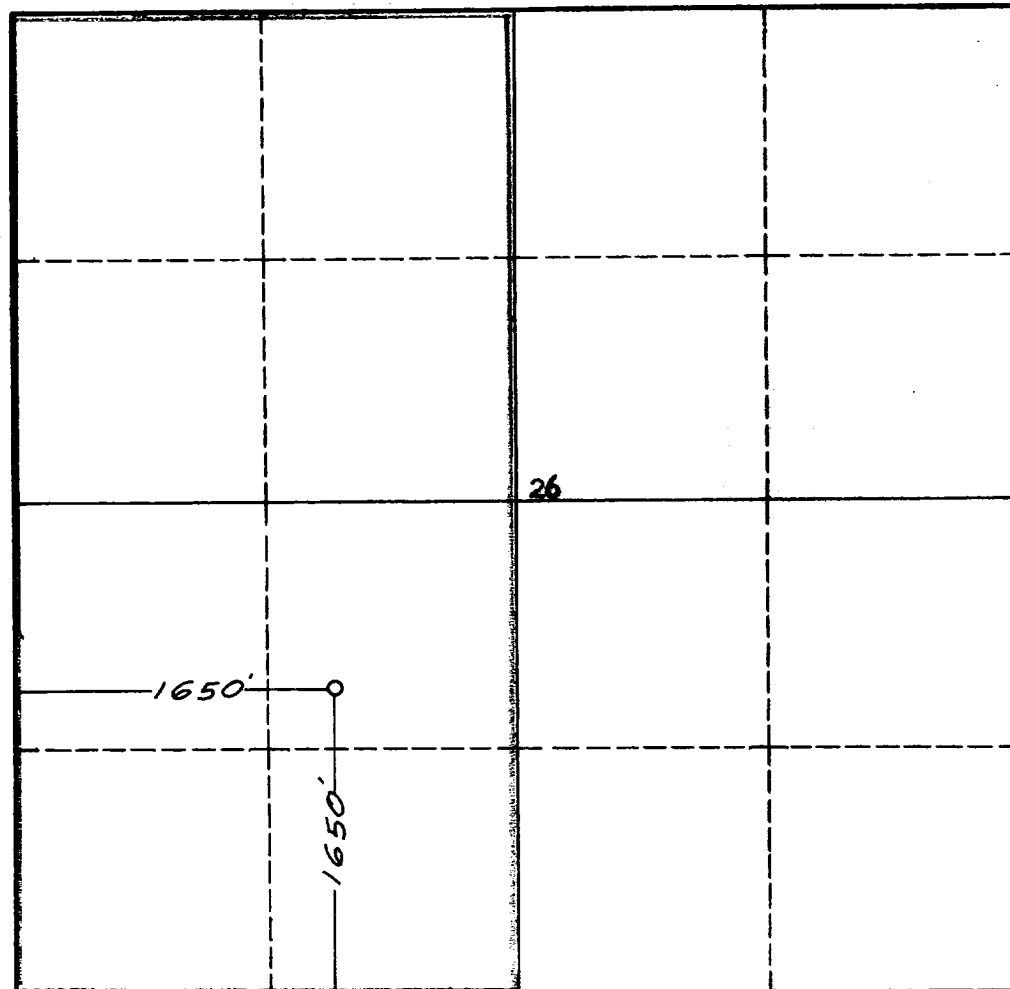

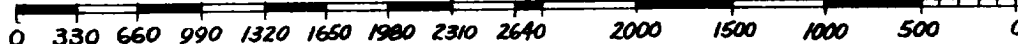
