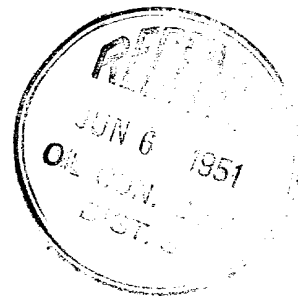

Dear Sir:

Stanolind Oil and Gas Company as operator under a certain oil and gas lease covering Federal Lands situated in the West Half of Section 23, T-27-N, R-10-W, Kutz Canyon Field, San Juan County, New Mexico, proposes to drill a well to the "ictured Cliffs Formation for development of gas in the NW/4 of Section 23.

The terrain in this immediate vicinity is extremely rough. Angels Peak occupying the greater portion of the NW/4 of Section 23 precludes the possibility of locating a drill site at any of the regular locations falling within the spacing pattern applicable to the Kutz Canyon Field. It is therefore necessary for topographical reasons to locate a well in this quarter section at an unorthodox location. We have surveyed the area and find reasonably suitable location at 990' from the West and 2310' from the North lines of Section 23. We therefore respectfully request approval to drill a well known as Stanolind Oil and Gas Company J. C. Jordan "C" #1, located 990' from the West and 2310' from the North Lines of Section 23, T-27-N, R-10-W, Kutz Canyon Field, San Juan County, New Mexico.

A surveyor's plat of the subject location is attached.
