

THE APPLICATION OF EL PASO NATURAL GAS COMPANY FOR PERMISSION TO EFFECT DUAL COMPLETION OF ITS CUCCIA STATE WELL NO. 3, LOCATED 890 FEET FROM THE SOUTH LINE AND 1090 FEET FROM THE WEST LINE OF SECTION 22, TOWNSHIP 27 NORTH, RANGE 8 WEST, NMPM, SAN JUAN COUNTY, NEW MEXICO, IN SUCH A MANNER AS TO PRODUCE GAS FROM THE SOUTH BLANCO PICTURED CLIFFS POOL AND THE PRODUCTION OF GAS FROM THE BLANCO MESAVARDE POOL.

ADMINISTRATIVE ORDER  
OF THE OIL CONSERVATION COMMISSION

Under the provisions of Rule 112-A (c) El Paso Natural Gas Company, made application to the New Mexico Oil Conservation Commission on July 25, 1958, for permission to dually complete its Cuccia State Well No. 3, located 890 feet from the South line and 1090 feet from the West line of Section 22, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico, in such a manner as to produce gas from the South Blanco Pictured Cliffs Pool and the production of gas from the Blanco Mesaverde Pool.

Now, on this 30th day of July, 1958, the Secretary-Director finds:

- (1) That application has been duly filed under the provisions of Sub-section 'c' of Rule 112-A of the Commission's Rules and Regulations;
- (2) That satisfactory information has been provided that all operators of offset acreage have been duly notified; and
- (3) That no objections have been received within the waiting period as prescribed by said rule.
- (4) That the proposed dual completion will not cause waste nor impair correlative rights.
- (5) That the mechanics of the proposed dual completion are feasible and consonant with good conservation practices.

IT IS THEREFORE ORDERED:

That the applicant herein, El Paso Natural Gas Company, be and the same is hereby authorized to dually complete its Cuccia State Well No. 3, located 890 feet from the South line and 1090 feet from the West line of Section 22, Township 27 North, Range 8 West, NMPM, San Juan County, New Mexico, in such a manner as to produce gas from the South Blanco Pictured Cliffs Pool and the production of gas from the Blanco Mesaverde Pool, through the casing-tubing annulus and the tubing respectively.

PROVIDED HOWEVER, That applicant shall complete, operate and produce said well in accordance with the provisions of Section V, Rule 112-A, as amended by Order No. R-1214.

PROVIDED FURTHER, That the operator shall make any and all tests, segregation and packer-leakage tests upon completion and annually thereafter during the Annual Deliverability Test Period for the Blanco Mesaverde Pool, commencing in the year 1959, and whenever the packer is disturbed, but not excluding any other tests and/or determinations as deemed necessary by the Commission.

IT IS FURTHER ORDERED, That jurisdiction of this cause is hereby retained by the Commission for such further order or orders as may seem necessary or convenient for the prevention of waste and/or protection of correlative rights;
