

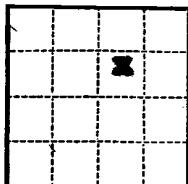

DETAILS OF WORK

Deepened with cable tools from 1335' to 1351' in the Dakota formation on 8-30-60. Completed open hole. Initial potential 9-16-60, pumping, 12 BOPD & 90 BWPD. Deepened with cable tools from 1351' to 1367' in the Dakota formation on 1-31-61. Completed open hole. Installed larger pumping equipment and established potential 2-2-61 of 80 BOPD & 250 BWPD.
